## STATEMENT OF WORK

## SW-1 DESCRIPTION OF WORK

- A. Work to be done: The works to be done consists of furnishing all plant facilities, labor, materials, and equipment and performing all work in strict accordance with these specifications to remove existing overhead curtain doors and install new high speed doors, at doors 4 and 6, on west side of building 373, located at Red River Army Depot, Texarkana, Texas.
- B. Location: The work site contemplated by these specifications is located approximately 18 miles west of Texarkana, Bowie County, Texas, on U.S. Highway 82. The main entrance to the depot is 0.3 mile south of Exit 206 on Interstate Highway 30.

SW-2 PRINCIPAL FEATURES: The work to be done includes the following principal features:

- A. Remove existing curtain doors #4 and #6 on west side of bldg.
- B. Install high-speed curtain doors in door #4 (10-ft X 14-ft) and door #6 (12-ft X 14-ft).
- C. Government electricians shall disconnect power to existing operators and shall wire new operators.
- D. Contractor shall complete work on one door before starting the next door.

SW-3 APPROVAL OF MATERIALS: Prior to ordering materials, the Contractor shall send material submittals to the Contract Officer, who will forward the submittals to COR for approval.

SW-4 SAFETY REQUIREMENTS: All OSHA Rules and Regulations apply to this project as well as local safety regulations.

SW-5 ON SITE VISIT: The Contractor is encouraged prior to submission of bid, to visit Red River Army Depot, Bldg. 373 during normal working hours to satisfy himself as the scope of work to be accomplished. The Contractor's failure to comply with this provision shall in no way relieve him of performing the work required under this contract. It is requested that the Contractor verbally advise the Contracting Officer at least twenty-four (24) hours in advance of his planned visit.

Coordinate directly with Mr. Doyce K. Martin to conduct a site visits. He can be contacted at (903) 334- 4568 to arrange for a site visit/survey.

## SW-6 SPECIAL REQUIREMENTS:

- A. Utility outages shall be minimized.
  - 1. All utility outages shall be approved by the Contracting Officer's Representative in writing prior to disruption of utilities.
  - 2. Contractor shall submit a proposed schedule of outages showing as a minimum: dates of outages, duration of outages and type of outages required.
  - 3. All utility outages required by the Contractor to accomplish his work shall be scheduled a minimum of 14 calendar days in advance.

- B. Time requirements for completion:
  - 1. Start Work: The Contractor shall start work within 30 calendar days after he/she receives the notice to proceed.
  - 2. Completion of Work: The Contractor shall complete work within 45 calendar days after he/she receives the notice to proceed.
  - 3. Contractor shall notify Government 7 days in advance of construction requiring movement of material from adjacent areas.
- C. Normal hours of work will be from 6:15 AM until 4:45 PM, Monday thru Friday (excluding holidays), unless Contract Officer Representative specifically approves other hours.

PART 2  
MATERIALS

1. CURTAIN: Curtain shall have at a **minimum** the following characteristics, **0.25-in thick styrene butadiene rubber. will have a polyester reinforcing weave center, with a minimum tensile strength of 3,800 psi**, capable of operation in temperatures ranging from -40 degrees Fahrenheit to 180 degrees Fahrenheit. The SRB fabric **must have a lifetime warranty**. Color: Blue, approved flame resistant, self-extinguishing SBR materials.

2. Side Frames & Windlok System: Heavy-duty steel side frames are 4-inch X 3-inch. The windlok and guide system allows for total structural integrity in negative or positive pressures and **high windloads of up to 88mph (20psf)**. The windlok system provides the door with a near airtight seal and no air infiltration between environments.

3. Break-Away Bottom Beam: The bottom beam shall be engineered to withstand very heavy impacts. Upon impact the bottom bar and curtain breaks away from the side frames. The bottom bar consists of a flat bar and steel angle that absorbs impacts and re-assembles within minutes without special tools or replacement parts. This significantly reduces downtime and maintenance cost.

4. Heavy Duty Drive Unit: The Operator shall be engineered for high cycle applications; the drive system shall produce opening speeds up to 36-inch per second with a 2-speed motor. The drives shall be UL/CSA approved with features such as: rotary screw-type limit switches, electro mechanical disc brake system and an emergency chain hoist. Built-in electrical interlock prevents motor operation during use of manual chain hoist.

4.1 Operator for door size 12-ft X 14-ft shall be 208 volts, 3 phase right hand operated.

4.2 Operator for door size 10-ft X 14-ft shall be 480 volts, 3 phase right hand operated.

5. Top Roll: An angled steel frame protects the top roll. The curtain must be capable of being rolled on a barrel of optimal size to carry the door load with a deflection of not more than .03-inch per foot of opening width. The curtains must have the following characteristics.

1. Counterbalanced: The door is evenly balanced with an oil tempered helical outboard torsion spring complete with a protective hood.
2. Springless: for high cycle applications (doors greater than 150-sq. ft. include an inertia brake with stop-lock feature for added safety). Supporting end brackets are constructed of ¼-inch hot-rolled steel plate with sealed, heavy-duty, self-aligning bearings with cast iron housings to support both the spring and idler barrels.

6. Control Panel: Control panel shall be nema-4 and UL listed (file E103891) control panel houses programmable logic controller (PLC). The controls shall be adjustable, with automatic closing timer, emergency stop, two actuating push buttons, a cycle counter, and two motion detectors.

7. Reversing Edge: The door must have an electric reversing edge and thru-beam photocell to stop and reverse the door when an object is in the doorway.

8. INSTALLATION:

1. Remove existing curtain doors.
2. New high-speed doors shall be installed in accordance with the manufacturer's instructions.
9. Cleaning: After installation of the doors the contractor shall clean up all debris, scraps, and other foreign matter create by Contractor.

TECHNICAL PROVISIONS  
SECTION 2A  
SPECIAL PROVISIONS

1. GENERAL: This section covers special contract requirements, not specifically defined elsewhere on the contract drawings or other sections of these specifications, which are manifestly necessary to carry out the intent of the drawings and specifications
2. COORDINATION OF WORK
  - 2.1 The Contractor shall execute work so as to interfere as little as possible with normal functioning of existing buildings or operation, including operations of utility services, fire protection systems and building equipment.
  - 2.2 Safety and Occupational Health requirements are included in the 'Special Contract Requirements' provided elsewhere in the contract document. Contractor shall become familiar with and shall demonstrate full compliance with all safety requirements specified in OSHA Parts 1910 and 1926, U. S. Army Engineer Manual 385-1-1, Army Regulations and Red River Regulations.
  - 2.3 Buildings occupied during performance of work: Contractor shall take all measures and provide all material necessary for protecting existing equipment, property, and ongoing operations in affected areas of construction against dust and debris.
3. APPROVAL OF MATERIALS AND EQUIPMENT: Before starting installation of any material, the Contractor shall submit to the Contracting Officer for approval, in quadruplicate, complete lists of materials and equipment to be incorporated in the work. The lists of materials and equipment shall be supported by sufficient descriptive material, such as catalogs, cuts, diagrams, and other data published by the manufacturer, to demonstrate conformance to the specification requirements; catalog numbers alone will not be acceptable.
4. UTILITIES:
  - 4.1 The Government will provide the Contractor, from existing outlets and supplies, all reasonably required amounts of utilities, as determined by the Contracting Officer. The Contractor shall carefully conserve utilities furnished without charge. The Contractor, at his own expense and in a workmanship manner satisfactory to the Contracting Officer, shall install and maintain all necessary temporary connections and distribution lines and shall remove the same prior to final acceptance of the construction.
5. HOURS OF WORK:
  - 5.1 Normal hours of work during the contract period shall be identical to the hours worked by the Contracting Officer or COR, unless the Contracting Officer specifically approves other hours. However, if the Contracting Officer/COR'S work schedule is altered during the contract period, the Contractor shall adjust his work schedule accordingly.

## 6. WARRANTY OF CONSTRUCTION:

- 6.1 General: In addition to any other warranties set out elsewhere in this contract, the Contractor warrants that work performed under this contract conforms to the contract requirements and is free of any defect of equipment, material or design furnished, or workmanship performed by the Contractor or any of his subcontractors or suppliers at any tier. The warranty shall continue for ten years from the date of final acceptance of the project. Under this warranty, the Contractor shall remedy at his own expense any such failure to conform or any such defect. In addition, the Contractor shall remedy at his own expense any damage to Government owned or controlled real or personal property, when that damage is the result of the Contractor's failure to conform to contract requirements or any such defect of equipment, material, workmanship, or the terms of this clause. The Contractor's warranty with respect to work repaired or replaced hereunder will run for ten years from the date of such repair or replacement.
- 6.2 Notification and Compliance: With in a reasonable time the Government shall notify the Contractor in writing after the discovery of any failure, defect, or damage. The failure of the Contractor to remedy any defect, or damage described in these specifications within a reasonable time after receipt of notice, the Government shall have the right to replace, repair, or otherwise remedy such failure, defect, or damage at the Contractor's expense.
- 6.3 Expressed Warranty: In addition to the other rights and remedies provided by this clause, all subcontractors', manufacturers' and suppliers' warranties expressed or implied, respecting any work and materials shall, at the direction of the Government, be enforced by the Contractor for the benefit of the Government. The Contractor shall obtain any warranties that the subcontractors, manufacturers, or suppliers would give in normal commercial practice. If so directed by the Contracting Office, the Contractor shall require any such warranties to be executed in writing to the Government.
- 6.4 Latent Defects: The warranty specified herein shall not limit the Government's rights under the Inspection and Acceptance clause of this contract with respect to latent defects, gross mistake, or fraud.

- (f) Late submissions, modifications, revisions, and withdrawals of offers:
- (1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.
  - (2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and--
    - (A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or
    - (B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or
    - (C) If this solicitation is a request for proposals, it was the only proposal received.

(ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.
